Part of Planning Scheme Map 49HO

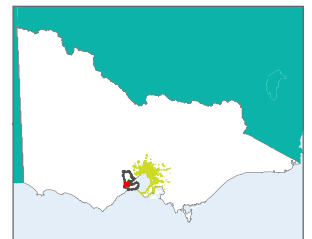

Part of Planning Scheme Map 9HO

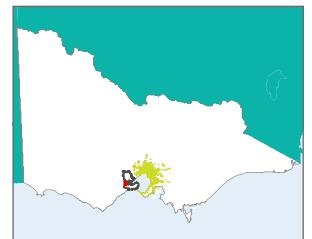
